Keiichi used to be a Partner at McKinsey & Company, Deloitte and PwC, where he specialized in financial services industry and technology strategies across North America, Europe, Southeast Asia and Japan.

Keiichi obtained his master's degree in engineering from Nagoya Institute of Technology majored in urban and transportation planning. He also holds MBA from the University of Warwick in the UK. He is a certified public accountant in the US.

#### Hiroshi Nakaso

#### FinCity. Tokyo Chairman

Hiroshi Nakaso was appointed chairman of a new organization to promote Tokyo as a global financial center. The new organization is known by its abbreviated name, "FinCity Tokyo". He was appointed chairman of the Daiwa Institute of Research (DIR) in July 2018 after completing his term as Deputy Governor of the Bank of Japan. He served as the Deputy Governor of the BOJ since March 2013.

In his 40 years at the Bank, his main responsibilities have been crisis management of financial systems and markets focusing on global systems. He dealt with the homegrown financial crisis of the 1990s. He headed the exit operation from the Quantitative Easing Policy, a prototypical unconventional policy that lasted from 2001 to 2006. In addition, he played an instrumental role in addressing the Global Financial Crisis together with his peers at major central banks including the FRB.

He holds BA in political science from University of Tokyo, MBA from Stanford Business School and Ph.D. in Management Science from Kyoto University.

After taking an early retirement from Osaka Gas in 2016, he held a number of research positions at Research Institute of Capital Formation of DBJ and at FSA institute in addition to running his own advisory company.

In 2021, he joined Rheos Capitalworks as director of Financial Inclusion. Ph.D. CMA.

Mathieu Klein became CIO of New Alpha Asset Management (Paris) following the acquisition in 2019 of Darius Capital Partners, an affiliate of Natixis IM where he was CIO & CEO.

New Alpha AM builds and advises portfolios of best-in-class external managers across asset classes, from public equities to private debt, on behalf of leading institutional investors.

Prior to Darius, Mathieu spent 13 years in investment banking in Paris, London, New York, and Tokyo. He was lastly responsible for the trading and distribution of international flow products in Asia for Lehman Brothers.

Previously he held positions as head of trading for Lehman Brothers and CCF in Paris, as well as senior credit trader for SG Warburg and CSFB in London.

He graduated with a finance degree from the Solvay Brussels School of Economics and Management.



Dr. Sam Y. Chung

Member of the Investment Policy Committee at the Korea National Pension Services & Head of Alternative Investment Funds Asia-Pacific (AIF APAC)

Sam Chung is a Professor of Finance at Yonsei University's Graduate School of Information in Seoul, Korea, where he developed and launched a graduate degree program in 'Artificial Intelligence & Diternative Investment' for the financial industry professionals in the country.

Prior to joining Yonsei University, he spent nearly two decades at Long Island University in NY, US as a Professor of Finance (tenured since 2005) and an associate Dean of the business school.

He had also served in the Chartered Alternative Investment Analyst (CAIA) Association as an Academic Advisor, the Center for International Securities and Derivatives Markets (CISDM) at the University of Massachusetts as a senior research associate, and the Journal of Alternative Investments as an Editorial Board Member.

Dr. Chung has advised AIF Global (www.aifglobal.org) for many years and is currently taking a leadership role as the head of AIF APAC.

He founded the Korea Alternative Investment Research Institute (KAIRI) and partnered with the Korea Financial Investment Association (KOFIA) to research various alternative investment asset classes and to educate both public and private investors. He has advised many Korean LPs including NPS, KIC, Korea-Post, and other Korean public and private asset owners. He has also advised Korea Financial Services Commission and Financial Supervisory Services regarding the Nation's Alternative Investments regulatory policies.

Dr. Chung received a Ph.D. in Finance from the University of Massachusetts- Amherst, M.S.F. from Boston College, and M.B.A. from Illinois State University.



Kirk Sims, CFA

Managing Director of Emerging Managers Program

TRS Investment Management Division, Teacher Retirement System of Texas

Kirk Sims heads TRS' Emerging Manager Program. Since being established in 2005, TRS has committed \$5.9 billion to one of the largest programs of its kind. An additional \$4.6 billion has been invested directly with EM Program graduates. Each graduate was selected as a result of consistent outperformance among a group of more than 218 EM managers.

Sims joined the Teacher Retirement System of Texas on March 1, 2019. Before joining Texas Teachers, he was a Senior Investment Officer for the Teachers' Retirement System of the State of Illinois. Sims had oversight and management responsibility of TRS's Emerging Manager Program, a \$750 million evergreen pool of capital designed to identify and invest in emerging investment managers across all asset classes.

Prior, Sims worked at Prudential Retirement where he was responsible for a manager of manager's retirement platform as well as an open architecture investment platform. He also has a background in asset management and has held various positions with both large and small asset managers.

Sims is a CFA charter holder and holds a Masters in Business Administration from the Columbia University Graduate School of Business. He received a Bachelor of Business Administration from Howard University in Washington, DC.




Ferenc Sanderson
